District Council 6 uses a variety of methods (physical, digital and personal) to ensure skilled, organized labor will again deliver a first-class product using safe, efficient practices in the field.

STRONGSVILLE - I am going to take this month to share how the IUPAT and DC 6 work together to serve our members and their families in Washington D.C., and to a lesser degree across the country.

Liz McElroy is the International Political Director and handles the political issues under the direction of General President Jimmy Williams, Jr. It is similar to how I serve under the direction of BMST Jim Sherwood.

I work cooperatively with Liz to accomplish the goals of the IU and DC 6, and that relationship is solid.

Clay Rodgers, from DC 3 in Kansas City works directly under Liz and is more of a day-to-day partner with me and DC 6. He works mostly in the central region and is a valuable asset to me and DC 6.

Lastly, **Britton Loftin** is the IUPAT lobbyist on Capitol Hill. I work with Britton from time to time to help with any Ohio or Kentucky congressional representative whom we are asking for support on a bill.

We are currently working together to get our Bridge Corrosion Prevention and Repair language attached to a larger bill, which could get it through to the President's desk.

One of our friends holds a key committee seat and we need her vote and support to get this out of committee.

#### FORCE ACCOUNTS

Last month, I wrote about the possible problems with Force accounts - the levels where county engineers need to bid the work to our contractors instead of self-performing that work.

The state transportation budget that came out of the House was fine, but the one that came from the Senate was worrisome.

The process now has the bill go to conference, where discrepancies will be ironed, which is happening as I write this article.

Once a compromise bill is

completed, both the House and Senate will vote on that updated version of the bill, which then goes to the governor.

The Governor does have a line-item veto, so he can veto any part of any budget bill. We will continue to work with ACT Ohio to protect our members' interests. This is not a five-alarm fire, but it could be harmful in the long run.

#### **NEW PETITION DRIVE**

Lastly, as I write this article, a group is attempting to codify a woman's right to control her own body and various medical decisions by gathering signatures to get the issue on the ballot in November.

This group got the minimal number of signatures needed to present the ballot language to the Attorney General, who apparently approved the language. This just means the language is clear and not misleading.

Now, this group must get close to 450,000 signatures in order to get the proposal on the November ballot. Expect to see them out in the public seeking these signatures, similar to our efforts with Senate Bill 5 a few years ago.

I stress, DC 6 will not take a side on this issue. We are simply alerting our members and their families to what this campaign is about.

Our members can then search their own conscious and decide whether to sign the petition.


Communicating with our members is a focus within DC 6.


