While passing House Bill 235, the High Hazard Training Certification Act, is a priority and one we hope to accomplish, we will be looking at elections all over Ohio and Kentucky.

There are U.S. Senate elections in Ohio and Kentucky where we have endorsed Tim Ryan in the Ohio Democratic Primary.

All U.S. House seats will be on the ballot, as will all of Ohio's statewide offices, including the governor.

Ohio Senate and House seats, and numerous Local positions will be contested. We will watch these races and will endorse, if it is appropriate.

As always, we will not look at anything except their positions on issues that involve our members' ability to earn living wages with benefits and their collective bargaining rights.

We do not support politicians so they can have a job. We do it so our members can have a job.

PENSION CHANGES

One of the major topics of current discussion in our union is the changes coming to our pension.

I am not going to comment on any of the changes, good or bad.

I recommend everyone read BMST **Jim Sherwood's** articles, come to the Local meeting or contact someone on staff to get the facts and your questions answered.

The point I want to make is, as always, politics play a major role in what is happening with our pension. You will hear terms like PPA, red zone and endangered status, among others. All of these terms, the notifications you


