STRONGSVILLE — This horrific COVID-19 pandemic has really shown the importance and the flaws of government in moments of crisis.

In Washington, the leadership at the White House has fallen well short of what we should expect, and the president simply did not take charge and guide us through this crisis.

There were powers available to him in times of crisis that could have been used to ensure the supply of needed tests, PPE and other critical supplies.

For whatever reason, the decision was made to not take charge at the federal level, which most believe should have happened.

In Congress, especially in the Senate, one side of the aisle wanted to bail out big business and not really help workers and small business. Friends of

ours fought hard to get the crumbs that came to us.

The one-time stimulus payment was very helpful, but not enough.

Our friend Rep. Tim Ryan, OH-13, led a group seeking monthly payments above the original amount until we can get back to some sense of normal.

The additional unemployment benefits were critical and very helpful.

However, this was included only after a group of mostly Democrats refused to discuss any package without it.

We tried to get help for our members and their insurance, like reimbursements or direct pay for members needing to self-pay their insurance due to unemployment and running out of bank. These were deemed a non-starter and part of a liberal wish list.

Requests for help with infrastructure funding, so we have jobs to return to, resulted in nothing.

In the end, any assistance for our families was a bare minimum.

Senate Majority Leader Mitch

McConnell and his fellow groupies could give and still get big money to corporate America.

In Columbus, many have applauded our Gov. Mike DeWine and Dr. Amy Acton, Director of the Ohio Department of Health, for their quick, decisive and honest actions with the citizens in Ohio. We share those beliefs and believe, in spite of the difficulties caused by their actions, these leaders have saved lives in Ohio.

However, as I write this on May 1, we have started reopening the state and the protesters in Columbus and voices on the right may be influencing these decisions.

The guidelines for businesses reopening appear to fall short of tough standards we really need, and many appear to be voluntary and at the discretion of those businesses.

History clearly shows if left to selfenforcement matters related to the safety of employees or the public, many businesses will not meet the standards


