We are thankful the General Executive Board of the IUPAT made accommodations to the Constitution's language, allowing us to carry on the business of the Council while still meeting the CDC guidelines.

To deliver the results of this meeting to the Local Unions, it will be necessary to hold Local meetings again. We are hoping to resume Local meetings in the month of July.

We have been forced to close all union meetings in April, May and June.

We at DC 6 want to insure you, the members, are in a safe environment while attending local meetings.

The DC 6 Communications Coordinator is getting the message out regarding when and how we will resume these vital components of our union.

In the meantime, please remember the COVID-19 pandemic is not over. It falls to each of us to protect one another. No one looks out for their own better than the IUPAT.

DC 6 BYLAWS

In March, we mailed out a copy of proposed DC 6 bylaws. This document is what dictates how the District Council is run. We had scheduled to vote on those bylaws in the month of April, but we were unable to do so, due to the coronavirus.

There were some minor changes in this document, including some to make us compliant with the IUPAT Constitution and some to lower dues.

The changes in the dues portion will reduce dues for 95 percent of the members of DC 6. We estimate a savings in excess of \$125,000 to the members.

We will send notice of when we will vote on these bylaws, hopefully in July.

As of the deadline to submit this article, DC 6 has experienced about a 20 percent reduction in hours and income to the Council, but rest assured, we are doing our best to cut spending and preserve hard earned dues money.

STRONGSVILLE - Last month, I started my article with this sentence: "This horrific COVID-19 pandemic has really shown the importance and the flaws of government in moments of crisis."

I then went on to compare politics in Washington to politics in Ohio.

I want to concentrate this month on Washington D.C., where support for our members and their family's financial health really lies.

Our members may be laid off, have job uncertainty, may be losing their insurance or even have long-term concerns about their pension benefits. All these concerns are legitimate and are issues the Governmental Affairs Department have been trying to address.

Let's be honest. What has our federal government done to date to assist us?

They have authorized trillions, ves trillions of dollars in aid, but gave laid off workers a short term \$600 a week benefit and gave us a one-time \$1,200 payment.

That's it. Everything else went to businesses or other government agencies.

We deserve better than the crumbs given to us to keep us from throwing them all out of office.

I have never in my years as your Governmental Affairs Director witnessed the entirety of the IUPAT work together as we have on this issue.

We made our demands for workers clear to everyone in the House of Representatives and they heard us and passed the HEROES Act, which had every demand we included.

It is not a perfect bill, but it will address all our issues.

In simple terms the HEROES Act provided for:

- · Another direct payment to our families, like the previous one, with the following change: families would receive \$1,200 per child instead of \$500.
- · An additional \$600 a week unemployment benefit, which would be extended until Jan. 2021. It is currently set to expire at the end of July.
- · Direct payment to our Health and Welfare funds for members, who are losing their insurance, to allow our laid off and distressed members families to maintain their insurance.
- · Pension relief.

We have long been supportive of the "Butch Lewis Act" to help support our pensions. This bill puts the Butch Lewis Act on steroids, and we strongly support it. The Act contains "GROW Act" pension language, which we do not support and hope to have removed. It is not a poison pill for us, however.

The Act also provides a small amount of infrastructure money and we hope more is added. We are glad some money is provided to put our members to work.

The Act would require OSHA to issue COVID-19 standards to protect our working members on the jobsite. This is critical to all future construction, for the safety of our members.

The Act also provides small business additional Paycheck Protection Program benefits to keep workers on the job. It will keep workers from being laid off and also extends to non-profits, making them eligible for the forgivable loans.

The Act provides funding for local and state governments to help them maintain our safety services - police and fire protections among them. We do not need those who serve and protect us laid off right now, either.

As you can see, the HEROES Act is geared to help working families like ours.

Not surprisingly, President Trump called this Act "dead on arrival" and Mitch McConnell called it a "liberal wish list."

We must be heard and force a vote in the Senate on this Act.

We will try to keep you as up to date as possible, but as you know, things are changing on almost a daily basis regarding new protocols.


