CENTRALIZED DUES COLLECTION

As of Jan.1, the process that began in 2014 as mandated

by IUPAT Constitution Section 162 (Centralized Local Union Dues, Records and Reporting) will be the law of the land for all Local Unions not already participating.

I recognize some Locals have been responsibly managing their own finances for decades, and this change may seem unnecessary and heavyhanded. Nonetheless, it was decided at the General Convention this will happen.

I appreciate the diligence with which the vast majority of Local Unions have handled their finances in the years leading up to this milestone.

The good news is that Locals will still be able to maintain a bank account and spend their own money as they see fit. The annual dues refund checks for those who have acquired excess forward payments (beyond six months) will be issued by DC 6 starting next year.

PENSION FUND

The details of the much-discussed Pension Fund changes are still being finalized by the Fund.

Until then, they do not want any formal reports given out.


STRONGSVILLE — After months of this Presidential Administration talking about it and years of previous administrations talking about it, we finally have an infrastructure bill!

We had great success with this policy, which we see in action on a regular basis in Columbus at the State House.

However, the extreme partisan politics in Washington has caused the Republicans DC 6 supported in the past to ignore us and vote against the members we represent.

We acknowledge and respect Sen. Rob Portman and Rep. Anthony Gonzales for their votes on the infrastructure bill, but we ask where were the other Ohio Republicans we supported in the past?

We also ask where were all the Ohio Republicans when the PRO Act was passed in the House? We are watching and your votes will not go unnoticed by us.

STATEHOUSE UPDATE

In Columbus, our priority now switches to Ohio House Bill 235, which will place strong requirements on Ohio's refineries.

These high hazard facilities do not make cotton candy, and they should be held to a higher standard when doing maintenance or improvement work.

Please keep your eyes on HB 235, call your state house representatives and state senators and tell then you support HB 235.

Remember, random drug tests are going out. Do not miss a random, which is equivalent to a fail.


