STRONGSVILLE — We are in the budget process in Columbus, a time that requires us to be diligent.

As the transportation and operating budgets are working their way through committees, the Ohio House and Senate and on to the Governor, there are multiple opportunities to harm our members and their families.

We always keep an eye out for amendments in committees that could weaken or eliminate Prevailing Wage, Project Labor Agreements or Community Benefit Agreements.

There could even be attempts to limit the work awarded to our contractors or our ability to collectively bargain for wages and benefits.

Although we are in a strong position in Columbus thanks to our partnership with ACT Ohio, we cannot take anything

One area that is always of concern, and is again this year, is Force accounts. This is simply the guidelines for county engineers that describes what work they can perform in house with their employees, and what they must bid out to contractors.

As I write this article, the largest expansion in the work they could selfperform is on the table. We believe we will be able to control any major expansion, but the fight is real.

This is a prime example of why our partnership with the other building trades affiliated with the Ohio State Building Trades and ACT Ohio is so critical to our success.

The old saying, "United we stand," is still true in 2023.

NEW PETITION DRIVE

Lastly, as I write this article, a group is attempting to codify a woman's right to control her own body and various medical decisions by getting the issue on the ballot in November.

This group got the minimal amount of signatures needed to present the ballot language to the Attorney General, who apparently approved the language. This just means the language is clear and not misleading.

Now, this group must get close to 450,000 signatures in order to get the proposal on the November ballot. Expect to see them out in the public seeking these signatures, similar to our efforts with Senate Bill 5 a few years ago.

I stress, DC 6 will not take a side on this issue. We are simply alerting our members and their families to what this campaign is about.

Our members can then search their own conscious and decide whether to sign the petition.


